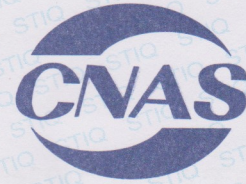

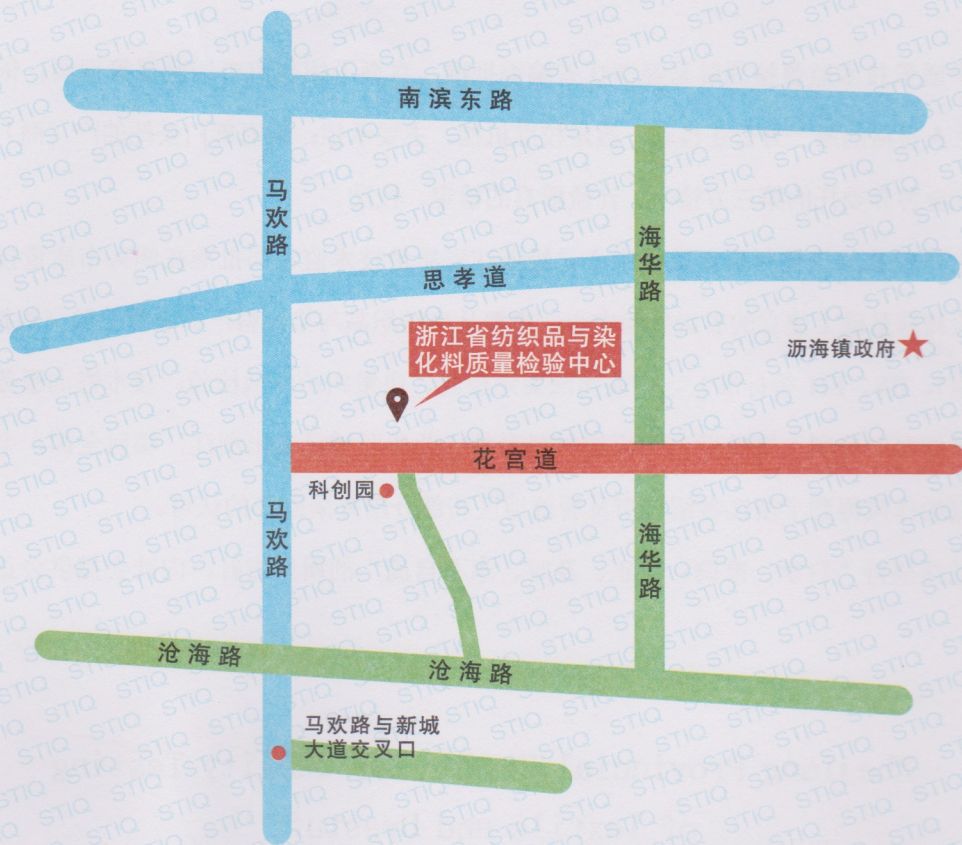

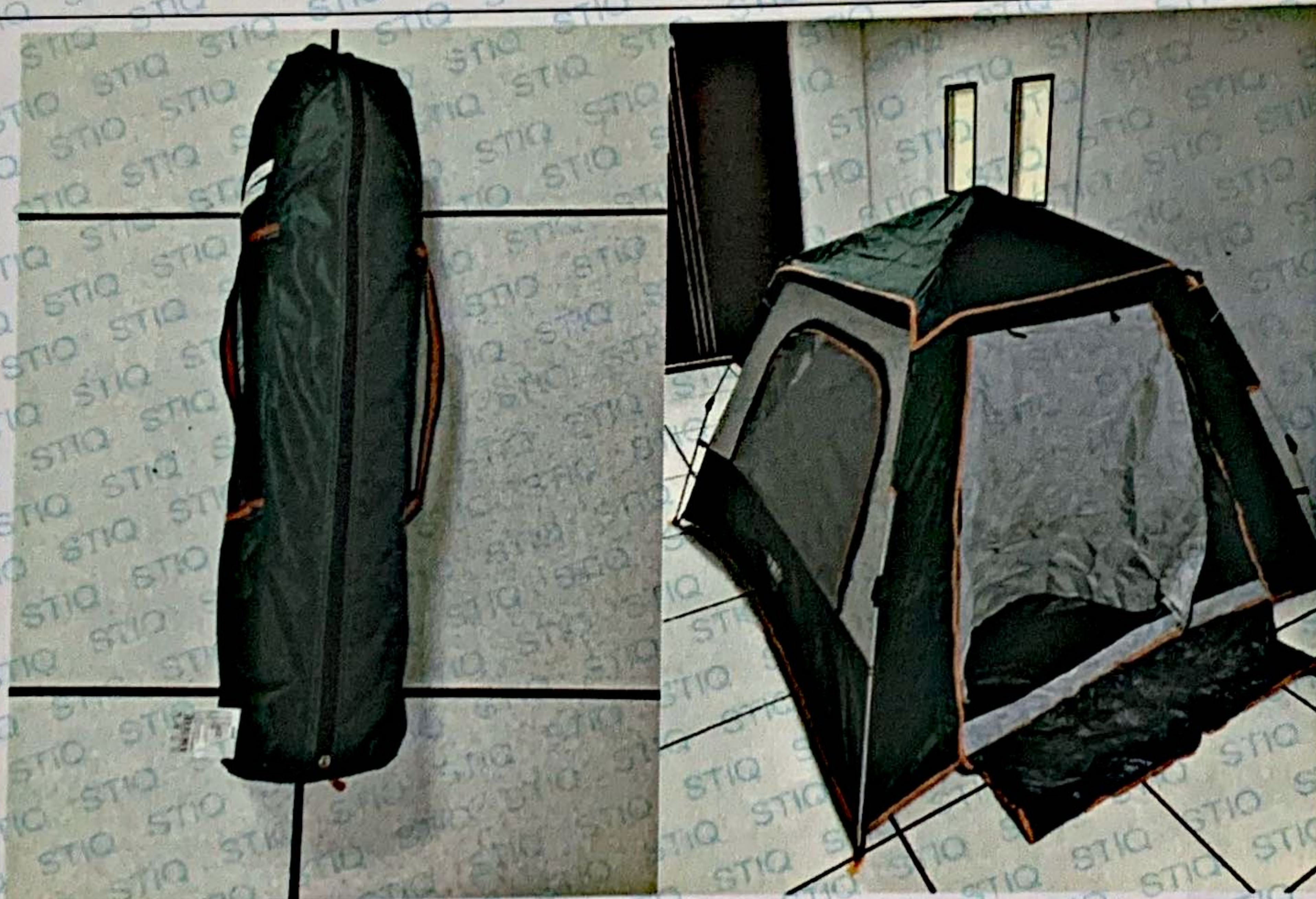

浙江省纺织品与染化料质量检验中心是经浙江省质量技术监督局批准在绍兴市质量技术监督检测院纺织检测部基础上建立的省级检验中心，主要从事纺织品与染化料产品质量检验（包括AATCC、ASTM、ISO、BS、EN 等标准）、产品司法鉴定检验、质量纠纷仲裁检验、技术咨询服务。检测业务涵盖了纺织品、染料、染整助剂等原辅材料产品，业务区域已走出浙江，辐射全国，中心高效的工作和严谨的作风得到了浙江省绍兴市及周边地区和部分国外采购商的认可。

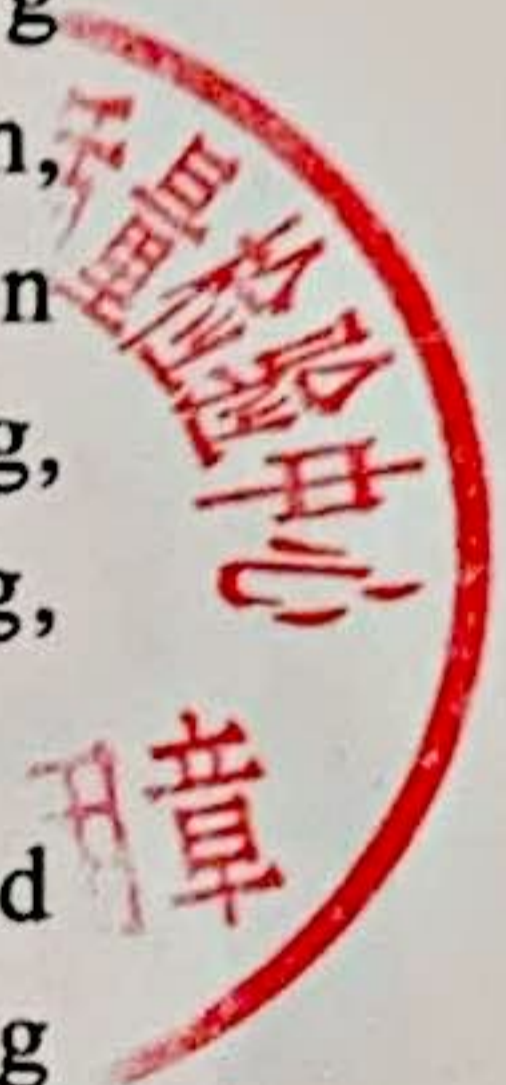
中心始终坚持“科学、准确、公正、及时、永不自满”的质量方针，向社会提供公正、诚信的检验服务。

## Zhejiang Provincial Center for Quality Testing of Textile and Dyestuff

Shaoxing testing institute of quality and technical supervision approved by the Zhejiang Provincial Ministry of Personnel, belonging to Shaoxing administration for market regulation, is an independent legal personality to the test of impartial third party certification calibration. Major operation: the government commissioned industry products control testing, the community commissioned third-party testing, measuring instruments inspecting, and calibration.

Textiles and Dyestuffs Testing Center of Zhejiang Province is a provincial level testing center approved by Zhejiang Bureau of Quality and Technique Supervision, and attached to Shaoxing testing institute of quality and technical supervision. The primarily testing operations of the center are: quality inspection on textiles and dyes (including standards such as AATCC, ASTM, ISO, BS, EN and etc.); judicial inspection on products, arbitrary testing over quality disputes, and technical consulting services. The center's testing businesses include testing on textiles, dyes, dyeing and finishing auxiliaries and auxiliary materials. The center's business has spread beyond Zhejiang to other areas of the country.
